Role - Recently, the Indian Prime Minister Narendra Modi has been announced by Bhutan to give the highest civilian honor (The 'Order of the Druk Gyalpo').

Exam Useful Points -

- It is the highest civilian award of Bhutan, which is given for people of Bhutan & for people who service to Bhutan.
- This award is given to Prime Minister Narendra Modi for serving the people of Bhutan and serving Bhutan.
- Prime Minister Narendra Modi was honored with awards from many other countries
 - Saudi Arabia - in 2016 - Order of Abdul Ajij Al Saud
 - Physical - in 2018 - Grand Collar Award
 - No. - In 2019 - Order of Janpad Award
 - Maldives - in 2019 - Special Rule of Nishan Izzudin
 - In the Room - 2019 - Order of St. Adreau Award
- The award was instituted on 7 November 2008 by the Bhutanese Namsayt Wangchuck.
- It is a landlocked country situated in the Bhutan Himalayas.
- It is a constitutional monarchy government.

Role:- The NDPS (Narcotic Drugs and Psychotropic Substances) Amendment Bill 2021 was passed in Parliament.

**Exam Useful Points -**

- The bill seeks to replace the one promulgated on 30 September this year.
- This bill was introduced by the government to rectify a mistake.
- Provision was made in section 27 of the Act, to punish those who finance illegal smuggling-
- This happened in 2014 when the Act was amended in 2014 to facilitate access to alcoholic beverages for medical needs.
- But the penal provision was not amended.
- The 2014 amendment had previously included sub-sections (i) to (v) of section 2 (ViiiA) of the Act in which the term illegal traffic was defined.
- This section was rewritten as the (ViiiB) clause in 2014. Because a new clause was inserted in section 2 defining the required narcotic drugs.
- However, inadvertently the consequential change was not made in section 27(A) of NDPS Act 1985.
- The NDPS was introduced in 1985, under which the storage of narcotics, sales, transport and any other type of activity is prohibited.
- This act allows the use of narcotic substances to a certain extent.
