- NHRC acts as a watchdog of human rights.
- This commission is a multi-member body, consisting of a chairman and seven other members, they are appointed by the President on the recommendation of a six-member committee headed by the Prime Minister.
- The United Nations General Assembly adopted the Paris Principles for the Protection of Human Rights in 1993.



- The Paris Doctrine is a set of international standards for assessing the credibility, independence and effectiveness of the NHRI, which directs all countries of the world to establish national human rights institutions.
- According to the Paris Principles, the Human Rights Commission shall be an autonomous and independent body. It also promotes human rights through media publications, training channels.
- Its function is to investigate the violation of human rights after receiving the petition or on the basis of self-cognizance.
- Can interfere with the judicial proceedings of any allegation related to violation of human rights.
- The National Human Rights Commission has the powers of a civil court, and can grant interim relief.
- The National Human Rights Commission takes up most of the issues in the country, Such as:- The issue of arbitrary arrest and detention, the issue of custodial torture, the issue of sexual violence and abuse, the issue of violence and discrimination against women and children, etc.

- The BRICS Ministers recognized the need for a strong agricultural research base in BRICS countries, the need to harness and share knowledge from laboratory to land, to ensure facilitation of transfer of technologies from laboratory to land. Consent was expressed.
- According to the Union Minister, BRICS countries are well positioned to play a leading role in helping to achieve the objectives of 2030 Sustainable Development Goals of eradicating hunger and poverty.
- This goal can be achieved by increasing agricultural production, thereby eliminating the problem of increasing income for farmers, income inequality and fluctuations in food prices.
- He noted the efforts made by India in conservation of agro-biodiversity through establishment and maintenance of national gene banks for plants, animals, insects, fish and agriculturally important microorganisms.
- India is also promoting diversification of Agri-food systems with the help of programs such as the National Bamboo Mission on Oilseeds, Pulses, Horticultural Crops and the National Mission on Palm.
