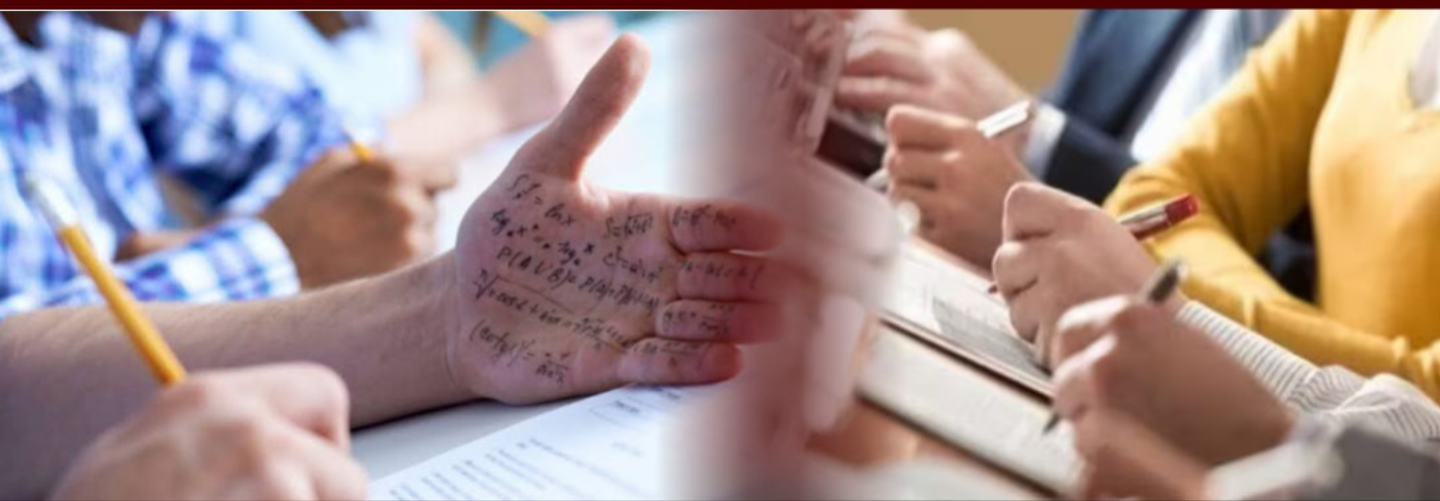

Public Examination means the examinations conducted by the Union Public Service Commission, Staff Selection Commission, Railway Recruitment Board, National Examination Agency and Central Government Departments.

- Its objective is to prevent any kind of collusion or conspiracy regarding unfair practices in examinations.
- According to various reports, more than 1.5 crore students have been affected by paper leaks from 2016 to 2023. More than 70 cases of question paper leaks have been reported in the same period.
- At least a dozen recruitment drives have been cancelled in the state between 2018 and February 2023 due to a paper leak.
- Since 2014, 615 accused have been arrested in 33 cases of government recruitment paper leak.

## ● Major provisions of the bill:

- The bill aims to bring greater transparency, fairness and credibility in public examination systems.
- The Bill provides for penalties for individuals, organized groups or institutions indulging in unfair means for monetary or unjust gain.
- However, candidates appearing in the examination have been kept out of its scope.
- The bill provides for a prison sentence of three to five years for involvement in paper leak cases.
- Section 3 of the Bill defines unfair means.

## Article 142 of the Constitution

- Recently, the Supreme Court used the power under Article 142 to seek the release of a man serving a 20-year jail sentence.
- The man was convicted under the Protection of Children from Sexual Offences Act (POCSO), 2012.
- This decision came after the curative petition was filed.
- A curative petition is the last option for the petitioner after the review petition is rejected on any decision.

### Article 142:-

- This article specifically empowers the Supreme Court to issue or pass any order which it deems necessary to render 'complete justice' in any case presented before it.
- Any judgment or order made under this article applies throughout the sovereign territory of India.
