• It provides for provision of relief and safety.

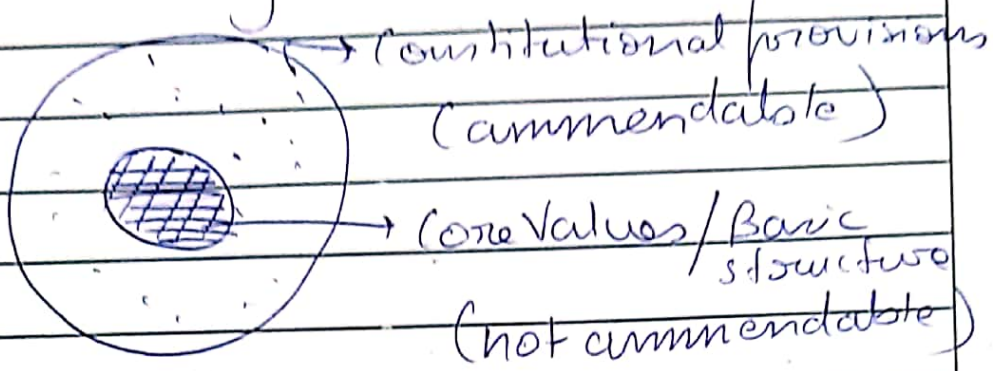
• Right to housing and residence
